Alongside her role as a legal case manager, Ms. Ma significantly contributed to the WIPO Center's development of a dispute resolution policy tailored to the specific needs China's national domain names. Thanks to the dedicated efforts of Ms. Ma and her colleagues, as of August 1, 2019, the WIPO Center has become the only non-Chinese entity to offer domain name dispute resolution services internationally for the .CN and .中国 (China) country code Top-Level Domains (ccTLD), which are among the world's largest ccTLDs.
